ellow Shareholders, Distinguished Ladies & Gentlemen, on behalf of the Board of Neimeth International Pharmaceuticals Plc., I welcome you to this 61st Annual General Meeting of our company. It is my pleasure to present the Annual Report for the 2019 financial year.

Neimeth's principal thrust is to contribute significantly to the health and wellbeing of our people through the manufacturing and marketing of pharmaceuticals, animal health, and general healthcare products that are of highest international standards and quality. This has and will always guide our interventions and key business decisions in the company.

Operating Environment

Uncertainty and high volatility characterised the 2019 global economic performance. Trade tensions, particularly between the United States of America (USA) and China, undermined growth. Trade tensions also intensified between the European Union and the US, as President Donald Trump's administration announced it would impose tariffs on a wide range of EU products. Against the backdrop of these uncertainties, the new International Monetary Fund (IMF) Chief Kristalina Georgieva said the global economic downturn had turned into a "synchronized slowdown".

The slow growth affected key sectors of global economy. In particular, it affected public companies and listings, with global IPO proceeds falling by about 22% in Q3, according to data from Price Waterhouse Coopers (PwC). Consequently, the International Monetary Fund reduced its global economic growth forecast to 3.0%, a 30 basis point reduction from its April 2019 outlook, the lowest global economic growth since the 2008-2009 financial crisis.

This "synchronized slowdown" was particularly evident in BRICS countries (Brazil, Russia, India, China and South Africa); each member experienced and is still facing major economic turbulence. India is facing severe economic slowdown. Brazil is growing at only 1.1% with no immediate signs of recovery. South Africa growth rate dropped to 0.8%, with soaring youth unemployment and high debts. China is experiencing slow growth mostly due to the impact of the trade war with the US. Russia is dealing with the US and EU sanctions resulting to low growth rate of 1.1%.

Growth in Sub-Saharan Africa moderated to a slower-than-expected 2.4% in 2019 from a 2.6% growth in 2018. Activity was dampened by softening external demand, heightened global policy uncertainty, and falling commodity prices. Domestic fragilities in several countries further constrained growth.

South Africa, Angola and Nigeria (the three largest economies in the region) experienced negative growth, remaining well below historical averages and contracting for a fifth consecutive year on per capita basis.

In South Africa, growth fell to 0.8%. This weak growth momentum reflected an array of overlapping constraints that included:

- Persistent policy uncertainty
- Constrained fiscal space
- Subdued business confidence
- Infrastructure bottlenecks especially in electricity supply
- Weakening external demand particularly from the Euro Zone and China.

Economic activity in Angola contracted by 0.7%, as oil output declined for the fourth consecutive year due to lower yields from aging fields and postponed investment in new capacity.

Economic activity in Nigeria was lack-lustre, as both macroeconomic policies and business environment remain unconducive to strong domestic demand. Growth remained broadly unchanged at 2%, as the agricultural sector continued to underperform due to the lingering insurgency in the North East and farmers-herdsmen clashes, while unreliable electricity supply continues to constrain manufacturing activities. The non-oil sector grew by 1.9%, less than growth from the previous year, due to the slow growth of major sectors like manufacturing as well as decline of other key sectors such as trade and real estate. Nonetheless, oil output increased, averaging 1.96 million barrels per day (a marginal increase from the 2018 daily average of 1.86 million barrels) but still below the budgeted output of 2.3 million barrels. This increase necessitated the 6.5% growth of the sector in Q3. The consistent decline in global demand for crude petroleum and the attendant price volatility impacted the economy negatively as the budget deficit margin continues to widen, thereby threatening fiscal sustainability.

The value of the African pharmaceutical market is growing rapidly, but the continent still imports over 70% - 90% of the pharmaceutical products it consumes - compared to 5% for China and around 20% for India. The continent only has about 375 drug manufacturers, mostly in the North African region, South Africa, Nigeria and Kenya. By contrast, China and India are thought to have about 5,000 and 10,000 manufacturers respectively. By 2020, the market could be worth between \$40bn and \$60bn, with over-the-counter, generic and prescription drug demand expected to grow.

Some of these statistics, though negative, throw up notable new opportunities we will push to explore in the coming years.

Results

At the end of the financial year, 30^{th} September 2019, total revenue stood at $\mathbb{N}2,371$ million, which is a 5% growth from the gross sales revenue of $\mathbb{N}2,269$ million in 2018. Profit before tax was $\mathbb{N}304$ million; when adjusted for corporate tax of $\mathbb{N}84$ million leaves us with profit after tax of $\mathbb{N}220$ million.

Balance Sheet Restructuring

Your company was unable to declare dividend this financial year under review despite the profit posted therein because the company wanted to avoid payment of cash dividend out of its capital and also to be in tune with regulation. This necessitated the Board coming up with the proposition to restructure the balance sheet of the company.

The restructuring will clear the accumulated losses in the statement of financial position of Neimeth, thus present a healthy state and open windows for dividend declaration in subsequent years to shareholders. Your support to this end is highly solicited to approve the proposal when called upon.

Awards & Recognition

Neimeth won the sectoral leadership award for the healthcare (pharmaceuticals) sector of the Nigerian Stock Exchange (NSE) at the 2019 Pearl Awards night. The award was based on the performance of quoted companies on the Nigerian capital market. Neimeth came top ahead of two other nominees – all leading pharmaceutical companies quoted on the NSE.

Also, our own Pharm. Matthew Azoji was named Business Day / Nigerian Stock Exchange top 25 CEOs in Nigeria in recognition of the performance of the company's shares on the Exchange.

The Pearl Award and others before it are testaments that will motivate the company to strive to do better. Our strategic plan is to move Neimeth from a good company to a great company.

The Board

Since the last Annual General Meeting, there have been some changes in the composition of the Board.

New Appointments

Pharm. Matthew Azoji fully assumed duties as the new Managing Director/CEO of our Company within the year. He joined the Company on February 1st, 2019, a few days before the last AGM. We can all affirm that he started on a stellar note; the Company recorded a year-on-year growth in both turnover and profit for the first time in years. In less than six months he was able to initiate an agenda for a 5-year strategic plan with the full support of the Board and Executive Managment, thereby starting the processs for vigorous expansion of the Company. This shows his capacity to lead the Company to greater heights. The Board has strong confidence in his leadership and commitment to creating value for all stakeholders. The Board appointed Mrs. Temitayo O. Nelson as the Executive Director, Finance and she assumed duty on 3rd June 2019. Prior to joining Neimeth, she functioned as the Chief Financial Officer (CFO) and Chief Risk Officer (CRO) at Chams Switch Limited, an e-payment company, leading the entire finance and risk management department between 2015 and 2018. She has since supported the company's strategic and operational requirements.

Retirement

The Board approved the retirement of Mr. Christopher U. Mmeje, who was the Executive Director, Finance with effect from October, 2019. Mr. Mmeje joined the company and the Board as Finance





Director in April 2008 and had a successful career serving as Ag. MD/CEO of the company between October 2017 and January 2019.

On behalf of the Board, every shareholder, the management and staff, I wish him the best in his new undertakings and assure him that Neimeth will forever be grateful for the active roles he played in the growth of our company.

Outlook of the coming year

Global growth is expected to edge up to 2.5% this year - a marginal shift from an estimated 2.4% in 2019, as trade and investment gradually recover. Emerging markets and developing economies are anticipated to see accelerated growth of up to 4.1% from 3.5% the previous year. But both trade and overall economic growth prospects remain vulnerable to flare-ups in U.S.-China and US-Euro trade tensions as well as rising geopolitical tensions in the country.

In Sub-saĥaran Africa, growth is projected to firm to 2.9% in 2020 and strengthen to 3.2% in 2021-2022. The growth pickup is predicated on improving investor confidence in some large economies, a strengthening cyclical recovery among industrial commodity exporters along with a pickup in oil production, and robust growth among several exporters of agricultural commodities.

In Nigeria, growth may increase up to +2.3% and current account deficit expected to persist. Minimum wage payment, new VAT rate and border closure will result in higher inflation. Inflation is expected to hover between 11.4% and 11.9%. We will anticipate widening forex restrictions plus inadequate local supply. Export revenue is expected to decline predicated on falling oil prices.

Strategic Vision for 2020-2024

Irrespective of the seemingly gloomy projected global and local economic outlook, we have articulated an audacious strategic plan that will aid the Company navigate this uncertain economic terrain. Our business objective for this year is to begin gradual expansion of our company's operations – manufacturing and marketing.

In 2019, we began the articulation of strategies meant to drive this vigorous expansion initiative. As a business, we are now better suited to re-enter the lucrative Nigerian Animal Health business, which has very robust volume and profit potentials. We expect to regain a controlling market share in few years. In addition, we plan to aggressively raise the market share of our flagship antiseptic/disinfectant, NCP to become one of the major drivers of the Company's growth both in the short to long term. We shall soon launch a 5-year strategic plan to reposition the company to play a greater role in the wider healthcare industry and ensure good returns on investment for shareholders.

Conclusion

Finally, I want to sincerely thank all our customers, suppliers, investors and shareholders for their support and hard work in 2019. Appreciation must also be extended to members of the Board and the Executive Management Team; whose tenacity and leadership ensure that we continue to live up to expectations and deliver on promises.

I thank each of Neimeth's employees who contribute their talent, energy and commitment to the achievement of our strategic objectives and I look forward to our continued partnership for an exciting year ahead.

Distinguished Shareholders, our esteemed Chairman and Directors, our greatly valued customers and staff, eminent guests, gentlemen of the press, ladies and gentlemen, I am honoured to present to you, our company's performance for the 2018/2019 financial year. As this is my first year of stewardship, I would like to start by thanking you, esteemed Shareholders, for investing in Neimeth International Pharmaceuticals Plc, and more importantly, for the trust and confidence you have placed in the Board and Management of the Company.

Operating Environment

In aggregate terms, the nation's GDP grew from +2.12% in the second quarter (Q2) of 2019 to +2.28% in Q3 2019. The GDP growth rate across industries improved in Q3 2019 but fell short of the Economic Recovery and Growth Plan (ERGP) target rate of +4.5% for the year. The implication was that the economy had recovered from an earlier recession, but needed a robust growth of above +3% to be ahead of the national population growth rate of which hovered between +2.6% to +3.2%. However, this was not so. 90.86% of GDP growth by Q2 was contributed by non-oil sector which was led by the services sector contributing 54.60% while the oil sector contributed 9.14%. There was a 5.15% year on year growth in the contribution of the oil sector to real GDP growth by end of Q2 2019.

Inflation started trending downwards in Q1 and Q2; in Q3, signs of a reversal was noticed as the Central Bank of Nigeria's (CBN's) restriction on food-related imports started putting pressure on local food prices and other manufacturing inputs. In January 2019, inflation stood at +11.37% and fell to +11.22% by the end of Q2. By July, the aggregate price level growth had slowed to +11.02%. The exchange rate remained relatively stable throughout 2019; with the Inter-bank Foreign Exchange Market (IFEM) and Bureaux de Change (BDC) rates averaging N306.95 and N359.94 to USD1.00 respectively. Access to foreign exchange for businesses including the manufacturing sector was also good during the year due to its continued availability which was fostered by the policy of Central Bank of Nigeria.

High interest rates, irregular power supply, poor transportation infrastructure, ever changing regulatory regime and persistent security challenges in different parts of the country continue to be major impediments to the growth and development of the manufacturing sector as well as the economy of the nation. These problems contributed significantly to the 0.13% year on year decline in the manufacturing sector seen by the end of Q2 2019 and to the growing unemployment rate now put at over 23% as well as poverty; thereby weakening the purchasing power of the populace. Weak purchasing power in itself has deleterious consequences on the growth and development of business.

Nigeria became one of the 54 countries that have signed the Africa Continental Free Trade Agreement (AFCTA) that integrated the country into a wider regional market. The Agreement is the second largest in the World in terms of participation covering 54 African countries. The agreement portends some advantages and disadvantages for the local economy – access to the larger continental market is considered the biggest advantage; while influx of low quality (cheap) products to the country that may pose significant challenge to the local manufacturing sector is considered the worst disadvantage. In order to appreciate the degree of apprehension among players in the industry, the Pharmaceutical Manufacturers Group of the Manufacturers Association of Nigeria (PMGMAN) has requested for a N300billion support from the Federal Government of Nigeria to enable its members upgrade their manufacturing facilities in order to compete effectively within the larger African market. PMGMAN members are worried that without such preparedness, Nigeria will end up a dumping ground for low quality products instead of becoming a net exporter to the rest of Africa.

In August, Nigeria unilaterally shut its land borders; a move the government said was to check smuggling into and out of the country. It is a laudable objective to stop smuggling because it hurts the





economy of the country. It has also generated considerable socio-economic implications for some of our neighbouring countries like Benin and Niger; who on their own should actually help Nigeria to discourage the illegal activities of smugglers by deliberate policy and not promote it by hinging their economic wellbeing on fallouts of same. On the other hand, it has worsened the congestion of Nigerian ports which led to major delays in the availability of imported raw materials for manufacturing and access of Nigerian export products to the ECOWAS regional market has also been diminished. It is hoped that appropriate actions will be taken by relevant Government agencies to ameliorate the difficulties faced by businesses as result of this policy while ensuring a net gain for the Nigerian economy.

Despite the challenges posed by the business environment, the Board and Management worked assiduously to ensure that your Company thrived to deliver more value to you and other stakeholders.

Healthcare and Pharmaceutical Sector

In 2019, the healthcare sector received only 3.9% from the entire national budget as against the Abuja Declaration of 2001, which recommended 15% for effective running of the sector. There was renewed hope in January 8 when President Buhari rolled out the Basic Healthcare Provisions Fund (BHCPF). The BHCPF is the 1% of federal government's Consolidated Revenue Fund and contributions from donor grants set aside to fund the basic healthcare needs of Nigerians. It is the fundamental funding provision under the National Health Act and was appropriated for the first time in the 2018 budget since the Act was signed in 2014. President Buhari had said at the launch that the disbursement of the fund and implementation of the programme will push the country towards achieving Universal Health Coverage (UHC). This development gave the much-needed boost to strengthen Primary Health Care in Nigeria. Consequently, the National Primary Health Care Development Agency (NPHCDA) in 2018 launched the Primary Health Care Under One Roof (PHCUOR) initiative, with the objective to integrate basic healthcare services under the umbrella of primary health care.

Hopefully, such commendable initiatives will be nurtured to improve overall funding for the health sector, enhance access to health services and others established; all aiming to reduce the current unacceptable level of out of pocket payment for health by Nigerians.

Financial Performance

At the end of the financial year 30^{th} September 2019, the company's gross revenue stood at \$2,371 million against annual sales of \$2,269 million for 2018; representing a 5% growth.




Figure 2: Evolution of PBT and PAT in Millions of Nigerian Naira: 2014 -2019

Your Company was not only able to achieve significant growth in earnings against the preceding financial year; there is also indication that it is moving out of losses into sustainable profitability.


Management has started putting measures in place to significantly reduce the performance volatility and sustain steady growth.

We devised a strategy for matching production with sales, such that production drives sales in as much as sales drives production. We succeeded in reducing the time the finished goods stay in the warehouse before sales, thereby significantly increasing the turnaround time of capital.

Within the year under consideration, the company's manufacturing plant produced total output valued at N2,035 million (vs. the N1,985 million in FY 2017/2018) representing a 3% growth in value of output but in actual volume output there was a growth of 22% over the preceding year.

The indices show that we have sustained the growth in productivity. More than 89% of sales were manufactured locally while the balance of less than 11% of turnover was on imported finished products. We intend to grow the plant output by a minimum of 70% in 12 months by upgrading the existing facility, improvement of production planning and inventory control and by putting more focus on risk management of plant equipment performance.





During the year under review Management paid significant attention to cost management in two major ways; namely, reduction of administrative expenses and increased absorption of overhead through enhanced production output from the factory.

The result of that effort was that administrative expenses dropped by \$167 million representing 45% reduction from the prior year figure of \$542 million to \$375 million for 2018/2019 financial year. There was a 4% increase in marketing and distribution expenses which is desirable to increase the demand of the Company's products. Figure 3 shows the trend of operational expenses for last five years, with sustained decrease in administrative expenses and slight increase in marketing and distribution expenses. In the next strategic plan of the Company more emphasis will be placed on further dropping of administrative expenses while on the other hand there will be more investment in the promotion of products in order to ensure that there is considerable growth in turnover and profits in the years to come.

Secondly overhead absorption which is a major contributor to profit for a manufacturing company grew by 28% from $\Re 225$ million for the previous year to $\Re 289$ million for the year under review. Figure 4 shows the trend for 5 years demonstrating the relationship between profit before tax (PBT) and overhead absorption. The 3 prior years with the least overhead absorption ended up in losses or little profit while the last 2 years with the highest overhead absorption had much higher profit outcomes.

Property at No 1, Henry Carr Street Ikeja

It was reported during the 2018 Annual General Meeting (AGM) that the Board decided to move all the staff of the Company in 2017 from its former head office at No. 1 Henry Carr Street, Ikeja to the Manufacturing facility in Oregun; principally to reduce overhead cost and to provide a more effective supervision and control of both the manufacturing, selling and marketing processes of the Company. These laudable objectives are being realized as demonstrated in the performance of the Company in the last two financial years. It is important to inform you, our distinguished shareholders that No. 1 Henry Carr Street was leased out to another Company, Euro Mega Nigeria Ltd which currently occupies the premises.

Successful Quality Management System (QMS) and Environmental Management System (EMS) Recertifications

Auditors of Standards Organization of Nigeria (SON) visited the Company recently for QMS and EMS audits. They were recertification audits based on the effective implementation of normative clauses of the requirements of ISO 9001:2015 Standard and ISO 14001:2015 standard for QMS and EMS respectively. Both the QMS and EMS recertifications were approved by SON.

Implementation of the Quality Management System (QMS) enables the Company to delight customers, increase customer trust and confidence, increase market share and reputation, enhance consistency in project success, increase production output, apply best practices and improve business processes. On the other hand, effective implementation of EMS helps the Company to minimize health, safety, environment incidents and reduces reputation risk. It is also now a fundamental requirement in some

tenders and processing of some bank loans; improves regulatory performance thereby lowering risk of fines for non-compliance with environmental legislation and many others.

Above all, effective implementation of both QMS and EMS will empower the Company to deliver greater value to Shareholders and other stakeholders.

Retirees

Management is delighted to report that all legacy pension and gratuity obligations owed all retirees of Neimeth including 3 former Directors which had lingered for many years have now been fully paid.

Outlook for the New Year

In 2020, growth in the Euro zone and US is expected to be weaker. With the January 31st exit of Britain from the EU, there is a growing concern of unfavourable trade deal with the EU, which is expected to account for slower than projected growth in the Euro zone. Geopolitical tensions will most likely disrupt the global supply chain. There will be potential tighter financial conditions with considerable adverse impact on vulnerable economies. Oil prices are likely to average \$57.9 from an average of \$61.8 per barrel in 2019 – oil futures contracts indicate that Brent prices will gradually decline to \$55 per barrel over the next five years. BRICS member countries will nearly account for 50% of world's economic growth as China is expected to be the main driver of growth in the year; though the full impact of the coronavirus epidemic on the Chinese and global economies is yet to be fully determined. The virus is already altering supply chains and disrupting companies across the world including our own. Economic experts have opined that the current level of disruption is manageable if the epidemic is brought under control; otherwise the upsurge in economic damage in China and the rest of the world will be rapid.





Nigeria's economy will continue its gradual recovery as GDP growth is expected to edge up to +2.3%; though still below the potential growth rate of +3.1%. Inflationary pressure will persist due to supply constriction resulting from the land borders closure, with direct impact on food prices. Again, CBN's reaction to continued pressure on the FX (higher than average money supply) may keep the core inflation sub-index higher. In all, we expect the headline inflation rate to average 11.9%, higher than 11.4% in 2019, while the benchmark interest rate (MPR) may remain unchanged. We imagine that the CBN will sustain its recent framework of heterodox policy mix until conditions necessitate policy normalization; hence, interest rates in the fixed income market may remain low, especially in Q1 of 2020.

The Federal Government presented for the first time the Finance Bill alongside the 2020 Budget, which made provisions for the increase of the national Value Added Tax (VAT) to 7.5%. The Bill got a speedy passage in the National Assembly and was subsequently signed into law. The new VAT regime took effect from February 2020. With the expected decline in crude oil prices, government will place more emphasis on alternative sources of revenue (taxes) for funding the 2020 budget. This is expected to increase the cost of business and put more pressure on the lean pockets of many Nigerians due to rise in prices of goods and services.

Nigeria now ranks 131 in the world on ease of doing business (moved up 15 places from its 2019 position) and has been tagged as one of the most improved economies in the world. The improvement reflects the ongoing reforms by the Federal Government towards improving the business environment.

Strategic Direction for 2020 - 2024

Having fully recovered from the 2017 fire disaster, which is evident in two consecutive years of profitability, our strategic focus this year will be to initiate bold and gradual expansion initiative that will see our Company playing more in the broader healthcare space. We; the Board and Management are about to complete a 5-year strategic plan that will guide our vigorous expansion programme – culminating in the upgrade of the current Oregun factory, development of new manufacturing facilities and expansion of our marketing drive to Sub-Saharan Africa. The strategic goals of this plan will be fully unveiled shortly.

To achieve the bold objectives being enunciated, we will make sizeable investments in the course of the fiveyear period. We might call on you for support (in terms of additional investments) to help us achieve the new targets. For my colleagues and I on the Board, we are very optimistic, even as we recognize the ever-increasing competition and other notable constraints in the industry. We are confident the set targets will be realized and the future of the Company is bright.

Appreciation/Conclusion

My utmost appreciation goes to our esteemed customers, who are the essence of our corporate existence. To you, esteemed Shareholders, I say thank for your unflinching support and faith in our company. I am deeply grateful to the Board whose oversight and guidance remain the bedrock of our strength. My heartfelt gratitude goes to my colleagues for their commitment to our promise of delivering value to all stakeholders. Above all we are most grateful to God for His Grace and Power. We are making noteworthy progress in our journey, but like you all know, we still have lots of grounds to cover and we will not rest until we are "*the leading innovative healthcare provider out of Africa*".

I am confident that we will achieve greater milestones in 2020, as we look forward to delivering superior returns to you at all times.



The intent of this report is to show how the affairs of Neimeth have been directed and controlled by the Board and to outline the corporate governance approach of the Board and activities that took place during the 2018/2019 financial year.

The Board is accountable and responsible to security holders for the performance of the Company's business. It defines the Company's strategic goals and ensures that the Company is well managed as it oversees and supports Management in its day to day running of the business.

The primary responsibility for ensuring good corporate governance in the Company lies with the Board, and it is committed to ensuring that the Company meets high standards of performance and governance in conducting its business. It is this commitment to high ethical conduct and best practices that has necessitated the practice of regularly reviewing our processes in order to align them with the applicable laws, rules and regulations in Nigeria, In particular, the Companies and Allied Matters Act (CAMA), Nigerian Securities and Exchange Commissions' Rules and Regulations on Code of Corporate Governance for public companies in Nigeria 2011(SEC Code) and the requirements of the 2018 Nigerian Code of Corporate Governance.

THE BOARD AND ITS COMMITTEES

The Board at all times aspires for excellence in governance standards, and in carrying out its responsibilities and duties as provided for in the applicable laws, rules and regulations and is supported by the Company Secretariat, headed by the Company Secretary/Chief Compliance Officer who advises and gives guidance to the Board. The Board is also supported by members of the Executive Management team to get appropriate information concerning the business. To aid Board effectiveness and full participation in decision making at Board and Committee meetings, Board papers are circulated in advance of such meetings. This also makes for robust discussions and well informed decision making. Where necessary, Board members are entitled to obtain independent professional advice at the Company's expense.

In performing its role, the Board is required to work as a team and meet on a regular basis. The Board is required to have a minimum of 4 Board meetings every year. The record of meeting attendance of the Board and its Committees in the year under review is contained in this report.

BOARD COMPOSITION

The Board in line with relevant provisions is of a sufficient size relative to the scale and nature of the Company's business, and is composed in such a way that ensures diversity of experience without compromising independence, compatibility, integrity and availability of members to attend meetings.

The Board is comprised of a mix of Executive and Non-Executive Directors, headed by a Non-Executive Director who provides leadership as Chairman of the Board. The majority of Board members are Non-Executive, one of which is an Independent Director. The Non-Executive Directors are independent of Management and exercise their judgment as Directors without any constraint.

All Directors are selected on the basis of certain core competencies, as well as knowledge, experience, integrity, diversity, leadership, reputation and ability to understand the company's business.

BOARD CHANGES

The Company's Articles of Association provides that the Company's Board shall consist of not more than thirteen directors. At the beginning of the 2018/2019 financial year, the Board comprised of 10 Directors, 8 of which were Non-Executive, with 2 Executive Directors. However, in the course of the year, two new Executive Directors were appointed. Pharm Matthew O. Azoji assumed office on the 1st of February 2019 and his appointment was ratified by members at the Annual General

Meeting of 6th February 2019, while Mrs Temitayo O. Nelson was equally appointed as Executive Director, Finance on the 14th of May, 2019, but assumed office on the 3rd of June, 2019. Her appointment will be ratified at the 2020 Annual General Meeting.

THE ROLE OF THE BOARD

The Board has adopted a Board Charter which sets out the role, responsibilities, structure and processes of the Board.

Specific matters reserved for the Board or its committees include:

- Composition of the Board and its Committees
- Approval of top executive appointments and top management succession plans
- Top management terms of employment
- The appropriation and distribution of profits
- Approval of Strategic plans
- Monitoring of information on major risks and exposures and final decisions regarding those exposures
- Acquisitions, disposals, mergers and joint ventures
- Major organizational or corporate changes
- Periodic and regular review of actual business performance relative to established objectives.
- Oversight of company operations
- Remuneration of executive directors
- Induction and training of new directors

SEPARATION OF THE POSITION OF CHAIRMAN AND MANAGING DIRECTOR

The positions of the Chairman of the Company and the Managing Director/CEO are occupied by separate persons. The MD/CEO is responsible for the day to day running of the Company.

RECORD OF DIRECTOR'S ATTENDANCE

In accordance with Section 258(2) of the Companies and Allied Matters Act Cap C20 LFN 2004, the record of Directors' attendance at board meetings during the year is available for inspection at the Annual General Meeting. The meetings of the Board were presided over by the Chairman. Written notices of Board meetings were circulated along with relevant Board papers, and minutes of meetings were appropriately recorded by the Company Secretariat team.

BOARD MEETINGS

The Board met at least once every quarter, however, an emergency meeting was scheduled to consider matters requiring the attention of the Board prior to the scheduled meeting for the next quarter. Meeting dates and attendance of each Director is reflected below.

MARKETS, PRODUCTS & DISTRIBUTION

THE NIGERIAN PHARMACEUTICAL MARKET

Pharmaceutical companies in Nigeria are up against several constraints, including challenges posed by infrastructural decay, government policies, sub optimal marketing, low capacity utilization, spiraling cost of business as a result of the high cost of inputs, low involvement in effective research and development etc. However, these pharmaceutical companies remain vibrant, with over 115 registered pharmaceutical manufacturers which in addition to providing dependable high-quality pharmaceutical products to medical professionals and patients in various communities in Nigeria and West Africa, have also contributed immensely to the economic growth of the nation.

Prior to the inception of drug manufacturing in the 1960s, pharmaceutical companies in Nigeria were dependent on large-scale importation of pharmaceuticals. Presently, some of these companies' manufacture various pharmaceutical dosage forms that cut across various therapeutic classes such as analgesics, anti-malarials, antibiotics, anti-retrovirals, antacids, haematinics, vitamins and minerals, cough and cold remedies, anti-diarrhoea, antihistamines anti-ulcer, antihypertensive, antidiabetics etc. These products are widely and readily available in registered hospitals, pharmacies and distribution outlets nationwide.

As Africa's largest economy, most highly populated country, and biggest consumer market, Nigeria has been hailed as the next frontier for pharma.

SALES DEPARTMENT

Neimeth sales and marketing business covers both the human pharmaceutical market and the veterinary market. In order for Neimeth to remain competitive in a very dynamic market such as in Nigeria, it has set operational and strategic business growth objectives. A new business structure came into existence in October 2019 for the purpose of expansion, focus and exploration of new business opportunities to withstand the rapid growing competition in the pharmaceutical market space. The new business structure is divided into four(4) basic Business Units which are (1) Ethical Business (2) Health Care Business (3) Personal Care Business and (4)Veterinary Business , structured into territorial markets for ease of management and control. Each of these Business Units is controlled independently by a Head of Business who is expected to run an individual entity charged with the responsibility of profit for the business.





THE COMPANY

The various Business Units are expected to target specific business areas which are:

(*i*) Ethical Business Unit: This Business Unit is expected to focus on the Prescription Only Medicines (POM) segment of the market and achieve high presence, usage and preference of Neimeth brands in hospitals. Products in this business segment require prescription from a healthcare practitioner for the final user to gain access to medication. This therefore requires adequate demand generation through various marketing activities engaged in by the field force in this business unit directed towards health care practitioners. Products in this category cannot be freely advertised in the open and lay media but only in selected medical and pharmaceutical journals/ magazines. Because of its limited advertising, focus is on one on one contact with the target audience who are usually the brand influencers for prescribing to the final users. These ethical brands include our flagship home grown product CIKLAVIT for the management of sickle cell disorder. In addition, products such as Normoretic, Amlovar, Norduet, Flucosyd, Flexodene, Tiocosid and new branded generics are part of the portfolio.

(*ii.*) <u>Healthcare Business Unit</u>: This Business Unit is focused on the pharmaceutical market segment involving pharmaceutical products that can be sold off the shelf without prescription. These products are referred to as Over the Counter (OTC) Medicines. Products in this business category can be easily advertised in open media such as television, radio, billboards etc. while field force marketing activities for this business category can also be done through professional medium form of demand generation such as clinical meetings and doctor and pharmacy calls. Due to the expanded advertising methods, the Healthcare Business Unit targets prescribers and brand influencers as well as the final consumers. Products sold under this business group include high volume products like Pyrantrin tablets, Pyrantrin suspension, Obron– 6, Homtamin G capsules, Nimartem tablets and Antimal tablets.

(*iii*) <u>Personal Care Business Unit</u>: This Business Unit is focused on the pharmaceutical market with products that have expanded use beyond pharmaceuticals, such as personal hygiene and health promotion. Most products in this business segment can be sold in pharmacies, supermarkets and other small stores. This gives opportunity for products to penetrate deeply in nook and crannies of the market environment. Products in this Business Unit comprises high volume drivers like NCP, our unique and user friendly brand of Antiseptic and Disinfectant with diverse usage profile. The Personal Care Unit represents a growth arm for the company in consideration of our quest for expansion of our products portfolio and reintroduction of some other products. Other well-known brands like Pancemol tablets our very effective brand of Paracetamol, Pancemol Syrup, Sportgesic Ointment, Gynotiocosid Vaginal Tablets and Tiocosid Cream, are potential volume drivers in this Business Unit.

(iv) <u>Veterinary Business Unit</u>: Neimeth in 1997 re-entered the lucrative Nigerian Animal Health Business, which has very robust volume and profit potentials. We introduced our own brand of poultry and large animal range of anthelmintic, as well as production enhancing medicaments. We also entered into strategic alliances in key disease areas that show great business potentials. We now expect to regain a controlling market share in few years. Products in this business segment include Maluminth Wormer, Piperazine Wormer, Neimycin Chick Formula, Neimycin Egg Formula, Neimycin Neo Soluble Powder, Neimycin Soluble Powder and Neivastress.

MARKETING DEPARTMENT

In order to re-establish the demand generation for all Business Units, the need for marketing support cannot be over emphasized. The need to move from a sales led organization to a marketing led organization was recognized

as a key driver to sustaining the new business model. Marketing-led companies focus on the key initiatives that will sustain growth in the new, buyer-driven environment. Two obvious hurdles that many companies experience during the shift to a marketing-led approach are cultural and financial commitments.





Cultural: Shifting to a marketing-led organization means that everyone not only marketing is to become the "voice of the customer." That means every employee now works with the company's and the customers' best interests in mind.

Financial: This goes beyond internal branding. There must be commitment to investing in the company and its infrastructure in an effort to better serve its customers and create a world-class customer experience and reputation. The Marketing Department aims to align its objectives with the company objectives which include, increased revenue generation, improved ROI at low cost, Develop company's own brand, Increase company overall product portfolio and deepen market penetration by opening up new channels. In so doing, there are two required strategic elements, which are Corporate Marketing and Product Branding.

Corporate Marketing is the aspect that deals with the company's brand identity as a whole. Corporate marketing brings about strong corporate brand equity and good will, which has a positive impact in the marketing of the company's product lines.

Product branding/Marketing is based on individual products marketing for increased demand generation across product distribution channels. Various aspects of the products are considered for proper positioning, demand generation, advertisement and promotions. Certain major tools shall be deployed in meeting up with the set objectives which are, marketing research tools, demand creation, product development tool, advertising & promotional campaign tools and business development tools.

In line with the new focus, a marketing team was set up and is headed by a Head of Marketing. The Marketing Department for the purpose of focus and in order to deploy the tools earlier mentioned has been further divided into four product portfolios that are managed by Product Managers. The product portfolios were designed to bring about specialization in the different product knowledge areas based on therapeutic segments directed towards specific target audience. The four product portfolios are (1) Internal Medicine Product Portfolio (2) Tropical Medicine Product Portfolio (3) Maternal & Child Health Product portfolio and (4) Healthy Living Product portfolio.

a) INTERNAL MEDICINE (INTERMED):

These are products that deal with diseases of the internal organs, Cardiovascular system and chronic illnesses .Products such as Anti hypertensives, blood disorders and others.

b) TROPICAL MEDICINES (TROMED):

These are products that take care of diseases common in the tropics that are recur from time to time. Products in this portfolio include Anti-malarial, Antibiotics and Antifungals.

c) MATERNAL & CHILD (MATCH):

These are products targeted at mother and child health. These products affect pregnancy, lactation and children's health. Products in this portfolio include Multivitamins for pregnant and lactating mothers, Intermittent Preventive Therapy (IPT) for malaria in pregnancy, Antimalarials and Deworming agents.

d) HEALTHY LIVING (HEALTH):

These are products used on a regular basis for quick remedy, first aid and health promotions. Products in this portfolio include products for stress management, pain, multivitamins and antiseptics/disinfectants

All Neimeth Pharmaceutical Product Portfolios fall into one of these specialty segments. Products are managed to deliver revenue and profits and marketing materials prepared to address these various areas of product segmentation. This also gives opportunity for products to receive adequate attention for the purpose of business growth through product development, product portfolio expansion and others. Product Managers are responsible for providing knowledge based support to sales teams across the





Business Units by providing strategic directions for product demand generation and sales. Some of these include, developing brand plans, developing content for clinical meetings, marketing materials and other related knowledge based supports to aid sales.

KEY ACCOUNT SEGMENTS: The Key Account Business in Neimeth is structured under two key segments:

- 1. Retail / Pharmacy Chain stores and Export
- 2. Government and Parastatals

In the Government segment, healthcare solution programmes like Helminthiasis Elimination Lower Cost Partnership (HELP) and Fight the Good Fight Against Hypertension (FITGAH) are well entrenched.

Business in the Government segment is executed in partnership with Government at all levels (Federal, State and Local), Non-Governmental Organization (NGOs), Professional bodies and Advocacy Groups on shared / lower cost basis.

ECOWAS MARKET

Neimeth is firmly on ground in the Anglophone West African Country of Ghana with renewed focus to expand into other countries such as Benin, Togo, Ivory Coast, Liberia and the Gambia. Our presence in the ECOWAS market is currently limited to pharmaceutical business with key products like Ciklavit, and NCP already registered.

SALES DISTRIBUTION

80 % of our products are distributed by World Wide Commercial Ventures Ltd. (WWCVL) also known as World Wide Healthcare Ltd with support from our Field Force whilst 20% are distributed by our Field Force. We have depots located in Lagos, Abuja, Ibadan, Onitsha, and Aba. These depots serve as our contact offices in these areas. Currently we have about 65 salesmen that cover all the 36 states of Nigeria. We also have key distributors and wholesalers who represent our interests in areas where our depots are absent. COMMUNITY SERVICE

Community consciousness is one of Neimeth's core values. To this end, Neimeth as a good corporate citizen has from inception till date engaged in various community-based welfare programmes that confirm its dedication to community health and wellness. The company has contributed significantly in helping to control worm infestation via numerous free de-worming programs and health education.

PYRANTRIN KIDS CLUB (PKC)

One of such health educational strategies is the Pyrantrin Kids Club (PKC). It is a health educational club

for children aged 4-13 years. It has been well documented that children serve as the main transmission link in worm infestation. Membership is spread across the 36 states of the Federation. It has numerous enviable membership benefits like birthday celebrations, scholarships and others. Membership strength is expected to grow in the coming years.

HELP

Another health educational strategy is the Helminthiasis Elimination Lower-Cost Partnership (HELP). This is Neimeth's social engineering programme aimed at improving the health, nutrition and welfare of Nigerians through the eradication of worm burden in our society. Like Pyrantrin Kids Club, it is structured on chemotherapy, sanitation, hygiene and health education .HELP is a mass de-worming partnership programme with NGOs, Governments, States, Ministries of Women and Social Development Outfits at a highly subsidized shared /lower cost.

FITGAH

The next community health educational programme is our "Fight the Good Fight Against Hypertension" (FITGAH). This programme enlightens Nigerians on the dangers of hypertension and diabetes and useful tips on ways to remedy them. It also offers half the price of hypertensive drug to those diagnosed with the health condition. The core of FITGAH programme is to offer free blood pressure check for people and treat identified hypertensive patients.

SMAPEX

Associated with this programme is the Stress Management Programme for Executives (SMAPEX) in which we emphasize the need for stress control by busy executives, to minimize the risk of exposure to insidious diseases like hypertension, diabetes etc.

RBM

The challenges and threats posed by the endemicity of malaria in our communities in Nigeria are well known. The Roll Back Malaria Programme (RBM) has been specially designed to take care of this problem considering that malaria is responsible for about 10% of children's death in hospitals and accounts for high mortality rate in pregnant women at an estimated 40%.

SICKLE CELL CLUB

Neimeth's focus on indigenous research into drugs and medicaments for common African disease ailments led to the discovery and launch of *Ciklavit*, a nutritional supplement for the management of Sickle Cell disorder. Consequent upon this, a well-orchestrated public enlightenment /advocacy machinery was established by the company to handle Sickle Cell disease related issues. Its activities include collaboration to facilitate the setting up of Sickle Cell Clubs in Local Government Areas across Nigeria, facilitating the management of these clubs in collaboration with other NGOs, demystification of the disease among rural communities as well as counseling of young and single people before marriage.

DRF

Neimeth has also put her technical expertise at the service of State Governments in the area of "Drug Revolving Fund (DRF)" management to ensure greater mileage in quality and reach of such state health programmes. Some states are beneficiaries of this medicare enhancement programme. The focus and cost effectiveness of these enlightenment and advocacy programmes make them most beneficial to the recipients and gives the highest visibility to government health programmes at highly subsidized rates.

RESEARCH & DEVELOPMENT

Neimeth has committed a substantial amount of money to Research and Development (R&D) in the recent past. Our effort in this area is double faceted: Internal and External.

Our Internal R&D activities include formulation of new products and re-formulation of existing products to:

- ➢ Enhance efficacy
- Create new therapeutic uses
- Increase sales potentials and profitability
- Expand usage extensions

Our External R&D work on the other hand entails working with medical scientists/researchers to develop new products, conduct drug clinical trials and in-vitro drug studies. These drugs could be natural, and/or chemical (synthetic), oral, or parenteral. To this end, we carry out research, working with our indigenous universities based on local raw materials, and focusing on specific disease areas that are generally neglected by global/multinational companies. We seek to provide new local health remedies in these areas at affordable costs. Our first success in this area is *Ciklavit*; the first homegrown natural product for the effective management of Sickle Cell Disease. Our Mission is to expand and grow the exportation of health solutions to other countries while meeting local needs.

MANUFACTURING & CERTIFICATIONS

Neimeth's manufacturing plant is installed to manufacture a wide range of pharmaceutical and veterinary products: tablets, capsules, ointment/creams, oral and consumer liquids, powders, and others in diverse packaging presentations.

The manufacturing plant is Good Manufacturing Practice (cGMP) compliant, as it is certified by NAFDAC and licensed to manufacture pharmaceuticals by the Pharmacist Council of Nigeria (PCN). The Plant is also equipped with in-house water treatment facility with de-ionization and distillation capabilities. We make continuous efforts in upgrading our plant and this is evident by our periodic restructuring and upgrading of the equipment and machineries to accommodate new opportunities that have emerged in form of excess capacity utilization for contract manufacturing, product customization and product analysis.

To further expand our manufacturing capabilities, Neimeth has also officially kicked off the construction of its Pharmaceutical Complex situated on an area covering 2.56 hectares of land in Anambra State.

Neimeth's has her products registered and available in other ECOWAS (Economic Community of West African States) countries and is therefore committed to meeting international best practice standards. The Company is currently **ISO 9001:2015**, **QMS: 0000296** and **ISO 14001:2015**, **EMS:0000024** certified.

In line with our commitment to be the leading Innovative healthcare provider out of Africa, Neimeth has ensured that all its operations are conducted in a manner consistent with relevant applicable laws. We are committed to a process of continuous improvement in all we do and to the adoption of international industry standards and codes wherever practical. Our efforts in the areas of HSE are directed by the



Neimeth ensures continuity and compliance by providing one month free provision of starter drugs (anti-hypertensives) for all isolated cases/subjects and partnership collaboration for six months to sustain the subjects.

Neimeth will continue to sustain her cardiovascular/FITGAH center at Oregun with the provision of free medical examination and management of hypertension subjects within her immediate communities. During the year under review, total number of 565 persons were examined and placed on Neimeth's anti-hypertensive products. No cash donation was made.

Every employee is regarded as unique and his impact is solicited and valued by Management. Employee and Management recognize that each employee is involved in running the business to provide quality products and services to our customers, shareholders and the community in which we operate.

Key to most employee involvement processes is team effectiveness, productivity, communication, problem solving, development of reward and recognition systems. In return, employees are treated equitably, fairly and with dignity as individuals in a consistent manner.

Our training is structured to meet needs of the employees to make them more effective on the job, change their attitude and interest, thereby promoting ownership. In this regard, evaluation of the effectiveness/ impact of the training is undertaken by Head of Departments six months post training in conjunction with Human Resource Department.

At Neimeth, we will continue to invest in training and development of employees to make them more productive and effective in their jobs, directly contributing to the bottom line.

HEALTH, SAFETY AND WELFARE OF EMPLOYEE

Environmental Management Policy

Neimeth is committed to operating its manufacturing system (production of healthcare and pharmaceutical products and support activities) in a safe and environmentally friendly manner. This ensures that the environmental impact of our production and related operations is controlled to ensure as little degradation as possible to the environment.

Accordingly, we constantly monitor our emission of green-house gases and ensure we reduce our carbon footprint through proper and periodic maintenance of our generators, proper servicing of our transport vehicles and through an annual corporate environmental objective which includes the planting of between two to five trees. Environmental audits are also carried out regularly and statutorily as required by law, at the end of which corrective and preventive actions are put in place to forestall any future occurrence.







This is achieved through the implementation of ISO 14001: 2015 and the continuous improvement of Environmental Management system (EMS)

Environmental Sustainability

At Neimeth, we make use of a wide range of resources like fuel, water and paper. The usage of these natural resources are monitored and measured and operational controls put in place to avoid wastages thereby promoting sustainability of these natural resources. In the case of water usage, this is achieved through the metering of the portable and de-ionized water lines and conducting regular leak audits which are quickly addressed. In 2018, the percentage water usage was 2.23% while in 2019, it was 2.28%, the marginal increase was as result of increased production and in the case of paper usage, sending more memos via emails than hard copies and the use of both sides of the paper has reduced the paper used annually thereby ensuring sustainable operations. On Energy Usage, a lot of improvement was also recorded.

We have done a lot in the area of waste to landfill management through the introduction of various initiatives and as such we have consistently maintained a waste to landfill percentage of 0.5% between 2018-2019, with continuous improvement on the forefront of our priority burner in subsequent years.

Some of these initiatives employ the three Rs technique of Re-use, Reduce and Recycle, this we have been able to achieve through the segregation of our waste as commingling of waste was formerly the order of the day. Some of the waste like nylon, paper and waste cartons are sold to middle men which becomes raw material for some other companies thereby converting waste to wealth. Some of the production waste from the natural products are sold to pig farmers and used as feed for the pigs.

The Extended Producer Responsibility (EPR) is our target whereby we will be responsible for the waste generated by the last item on our production process.

Health & Safety

At Neimeth, we are committed to conducting our manufacturing processes in a safe and accident free environment for all employees, contractors and visitors.

We have built a safety culture in our personnel through regular trainings, teaching them that their safety is in their hands and that safety is everybody's responsibility and not only a function of the management.

The Management has on its own part made tremendous strides towards the provision of various controls both engineering and administrative and has also made adequate provision of PPEs (Personal Protective Equipment) for employees. The target is to have a zero accident environment where the employees come to work safe and go back same. Visual aids in the form of safety signs have been made in the simplest forms and language so that even the unlettered can decipher them. Employees are encouraged to report near misses and accident investigations are carried out accordingly and CAPA (Corrective and Preventive Actions) are put in place. This giant stride is a huge improvement from 2018.

In 2018, 1 Lost Time Accident was recorded for a Full Time Staff, while in 2019, 1 Lost Time accident was also recorded. Our target is Zero accidents. Management has embraced safety, such that a week- long activity was introduced in 2018 where various safety trainings were given to personnel, as well as first aid training.

Neimeth HIV/AIDS Policy

Neimeth has adopted a policy with a commitment to prevent the spread of HIV/AIDS in our workplaces and to care for the personnel and their dependents who suffer from its effects.

To guide Neimeth Management in addressing the challenges of managing HIV/AIDS in the work place, this policy therefore seeks:

• To create programs in conjunction with other appropriate agencies to prevent the scourge of this disease which include education and awareness program.





- To guide managers, supervisors and workers on the best practice in ensuring harmonious work relationship between employee(s) with HIV/AIDS and other employees.
- To emphasize on the level of reasonable accommodation the company can provide employees with life threatening illness that would not be detrimental to the smooth operation of the company's business, and
- Promote confidentiality and non-discrimination towards employees with HIV/AIDS thereby promoting appropriate and effective ways of managing HIV/AIDS in the workplace.
- Avoid stigmatization meted out to employees living with HIV/AIDS through ensuring that their status is kept confidential.

1. The Company

1.1 Legal form

Neimeth International Pharmaceuticals Plc, a Company quoted on the Nigerian Stock Exchange was incorporated on 30 August 1957 as a limited liability company and commenced operation in January 1958. On 14 May 1997, Pfizer Inc. NY divested from the Company through a management buyout.

1.2 Principal activities

The principal activities of the Company are manufacturing and marketing of pharmaceuticals and animal health products.

2. Basis of preparation

2.1 Statement of compliance

These financial statements have been prepared for the year ended 30 September 2019 in accordance with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standard Board (IASB) and in compliance with the Financial Reporting Council of Nigeria Act, No 6, 2011. Additional information required by local regulators has been included where appropriate.

2.2 Basis of measurement

The financial statements have been prepared in accordance with the going concern principle under the historical cost convention, except for financial instruments and land and buildings measured at fair value.

The preparation of financial statements in conformity with IFRS requires the use of certain critical accounting estimates, it also requires management to exercise its judgment in the process of applying the accounting policies. Changes in assumptions may have a significant impact on the financial statements in the year the assumptions changed. Management believes that the underlying assumptions are appropriate and therefore the financial statements present the financial position and results fairly.

2.3 Going concern assessment

The financial statements have been prepared on a going concern basis, which assumes that the entity will be able to meet its financial obligations as at when they fall due. There are no significant financial obligations that will impact on the entity's resources which will affect the going concern of the entity. Management is satisfied that the entity has adequate resources to continue in operational existence for the foreseable future. For this reason, the going concern basis has been adopted in preparing the financial statements.

2.4 Functional and presentation currency

These financial statements are presented in Naira, which is the company's presentational currency. The financial statements are presented in the currency of the primary economic environment in which the Company operates (its functional currency).

2.5 Summary of Standards and Interpretations effective for the first time

2.5.1 IFRS 16, Leases

Effective for annual periods beginning on or after 1 January 2019:

- New standard that introduces a single lessee accounting model and requires a lessee to recognise assets and liabilities for all leases with a term of more than 12 months, unless the underlying asset is of low value. A lessee is required to recognise a right-of-use asset representing its right to use the underlying leased asset and a lease liability representing its obligation to make lease payments. A lessee measures right-of-use assets similarly to other non-financial assets (such as property, plant and equipment) and lease liabilities similarly to other financial liabilities. As a consequence, a lessee recognises depreciation of the right-of-use asset and interest on the lease liability, and also classifies cash repayments of the lease liability into a principal portion and an interest portion and presents them in the statement of cash flows applying IAS 7 Statement of Cash Flows.
- IFRS 16 contains expanded disclosure requirements for lessees. Lessees will need to apply judgement in deciding upon the information to disclose to meet the objective of providing a basis for users of financial statements to assess the effect that leases have on the financial position, financial performance and cash flows of the lessee.







- IFRS 16 substantially carries forward the lessor accounting requirements in IAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently.
- IFRS 16 also requires enhanced disclosures to be provided by lessors that will improve information disclosed about a lessor's risk exposure, particularly to residual value risk.
- IFRS 16 supersedes the following Standards and Interpretations:
 - a) IAS 17 Leases;
 - b) IFRIC 4 Determining whether an Arrangement contains a Lease;
 - c) SIC-15 Operating Leases-Incentives; and
 - d) SIC-27 Evaluating the Substance of Transactions Involving the Legal Form of a Lease.

Impact on Initial Application

These standard does not have any impact on the entitys' financial statements.

2.5.2 Uncertainty over Income Tax Treatments (IFRIC Interpretation 23)

In June 2017, the IASB issued IFRIC Interpretation 23 Uncertainty over Income Tax Treatments in response to diversity in practice for various issues in circumstances in which there is uncertainty in the application of the tax law. While IAS 12 Income Taxes provides requirements on the recognition and measurement of current and deferred tax liabilities and assets, there is diversity in the accounting for income tax treatments that have yet to be accepted by tax authorities.

The Interpretation requires an entity to:

- reflect an uncertainty in the amount of income tax payable (recoverable) if it is probable that it will pay (or recover) an amount for the uncertainty;
- measure a tax uncertainty based on the most likely amount or expected value depending on whichever method better predicts the amount payable (recoverable);
- reassess the judgements and estimates applied if facts and circumstances change (e.g. as a result of examination or action by tax authorities, following changes in tax rules or when a tax authority's right to challenge a treatment expires); and
- consider whether uncertain tax treatments should be considered separately, or together as a group, based on which approach provides better predictions of the resolution;

The Interpretation is applicable for annual periods beginning on or after January 1, 2019.

Impact on Initial Application

The amended to the standard might not have any impact on the entity's financial statements when it becomes effective in 2019.

2.5.3 IFRIC Interpretation 23 Uncertainty over Income Tax Treatments

In June 2017, the IASB issued IFRIC Interpretation 23 Uncertainty over Income Tax Treatments which clarifies application of the recognition and measurement requirements in IAS 12 Income Taxes when there is uncertainty over income tax treatments. Scope The interpretation addresses the accounting for income taxes when tax treatments involve uncertainty that affects the application of IAS 12. The interpretation does not apply to taxes or levies outside the scope of IAS 12, nor does it specifically include requirements relating to interest and penalties associated with uncertain tax treatments. Key requirements The interpretation specifically addresses the following:

- · Whether an entity considers uncertain tax treatments separately;
- The assumptions an entity makes about the examination of tax treatments by taxation authorities;
- How an entity determines taxable profit (tax loss), tax bases, unused tax losses, unused tax credits and tax rates;
- How an entity considers changes in facts and circumstances.

An entity has to determine whether to consider each uncertain tax treatment separately or together with one or more other uncertain tax treatments. The approach that better predicts the resolution of the uncertainty should be followed.







Effective date and transition The interpretation is effective for annual reporting periods beginning on or after 1 January 2019, but certain transition reliefs are available.

2.5.4 Prepayment Features with Negative Compensation - Amendments to IFRS 9

Key requirements Under IFRS 9, a debt instrument can be measured at amortised cost or at fair value through other comprehensive income, provided that the contractual cash flows are 'solely payments of principal and interest on the principal amount outstanding' (the SPPI criterion) and the instrument is held within the appropriate business model for that classification.

The amendments to IFRS 9 clarify that a financial asset passes the SPPI criterion regardless of the event or circumstance that causes the early termination of the contract and irrespective of which party pays or receives reasonable compensation for the early termination of the contract.

The basis for conclusions to the amendments clarified that the early termination can result from a contractual term or from an event outside the control of the parties to the contract, such as a change in law or regulation leading to the early termination of the contract. Transition - The amendments must be applied retrospectively; earlier application is permitted. The amendment provides specific transition provisions if it is only applied in 2019 rather than in 2018 with the rest of IFRS 9.

Effective date and transition The interpretation is effective for annual reporting periods beginning on or after 1 January 2019.

2.5.5 Plan Amendment, Curtailment or Settlement - Amendments to IAS 19

Key requirements The amendments to IAS 19 Employee Benefits address the accounting when a plan amendment, curtailment or settlement occurs during a reporting period. Determining the current service cost and net interest When accounting for defined benefit plans under IAS 19, the standard generally requires entities to measure the current service cost using actuarial assumptions determined at the start of the annual reporting period. Similarly, the net interest is generally calculated by multiplying the net defined benefit liability (asset) by the discount rate, both as determined at the start of the annual reporting period. The amendments specify that when a plan amendment, curtailment or settlement occurs during the annual reporting period, an entity is required to:

- Determine current service cost for the remainder of the period after the plan amendment, curtailment or settlement, using the actuarial assumptions used to remeasure the net defined benefit liability (asset) reflecting the benefits offered under the plan and the plan assets after that event;
- Determine net interest for the remainder of the period after the plan amendment, curtailment or settlement using: the net defined benefit liability (asset) reflecting the benefits offered under the plan and the plan assets after that event; and the discount rate used to remeasure that net defined benefit liability (asset) Effect on asset ceiling requirements.

A plan amendment, curtailment or settlement may reduce or eliminate a surplus in a defined benefit plan, which may cause the effect of the asset ceiling to change. The amendments clarify that an entity first determines any past service cost, or a gain or loss on settlement, without considering the effect of the asset ceiling. This amount is recognised in profit or loss. An entity then determines the effect of the asset ceiling after the plan amendment, curtailment or settlement. Any change in that effect, excluding amounts included in the net interest, is recognised in other comprehensive income. This clarification provides that entities might have to recognise a past service cost, or a gain or loss on settlement, that reduces a surplus that was not recognised before. Changes in the effect of the asset ceiling are not netted with such amounts.

Transition: The amendments apply to plan amendments, curtailments, or settlements occurring on or after the beginning of the first annual reporting period that begins on or after 1 January 2019.







2.6 Standards and interpretations issued/amended but not yet effective

At the date of authorisation of these financial statements the following standards, amendments to existing standards and interpretations were in issue, but not yet effective: This includes:

2.6.1 Applying IFRS 9 Financial Instruments with IFRS 4 Insurance Contracts

IFRS 17 is effective for annual periods beginning on or after January 1, 2021, well after the effective date of IFRS 9 Financial Instruments, January 1, 2018. IFRS 9 will cover a majority of an insurer's investments; therefore, the expected differing effective dates created concerns related to temporary volatility and accounting mismatches in profit or loss. Some companies have also expressed concerns about the need to implement two significant changes in accounting on different dates, which will increase costs and complexity.

In September 2016, the IASB issued amendments to its existing insurance contracts standard, IFRS 4. The amendments introduced two approaches that supplement existing options in the Standard that can be used to address the temporary volatility as a result of the different effective dates of IFRS 9 and the forthcoming insurance contracts standard.

The amendments:

- provide a reporting entity (whose predominant activity is to issue insurance contracts) a temporary exemption from applying IFRS 9 until the earlier of: a) the application of IFRS 17; or b) January 1, 2021 (to be applied at the reporting entity level) (referred to as the 'temporary exemption'); and
- give entities issuing insurance contracts the option to remove from profit or loss the incremental volatility caused by changes in the measurement of specified financial assets upon application of IFRS 9 (referred to as the 'overlay approach'). This option will be in place until IFRS 17 comes into effect.

Impact on Initial Application

The amendment to the standard might not have any impact on the entity's financial statements when it becomes effective in 2021

2.6.2 Conceptual Framework for Financial Reporting

Purpose:- The revised Conceptual Framework for Financial Reporting (the Conceptual Framework) is not a standard, and none of the concepts override those in any standard or any requirements in a standard. The purpose of the Conceptual Framework is to assist the Board in developing standards, to help preparers develop consistent accounting policies if there is no applicable standard in place and to assist all parties to understand and interpret the standards.

Key provisions:The IASB issued the Conceptual Framework in March 2018. It sets out a comprehensive set of concepts for financial reporting, standard setting, guidance for preparers in developing consistent accounting policies and assistance to others in their efforts to understand and interpret the standards. The Conceptual Framework includes some new concepts, provides updated definitions and recognition criteria for assets and liabilities and clarifies some important concepts. It is arranged in eight chapters, as follows:

The Board has also issued a separate accompanying document, Amendments to References to the Conceptual Framework in IFRS Standards, which sets out the amendments to affected standards in order to update references to the Conceptual Framework. In most cases, the standard references are updated to refer to the Conceptual Framework.







There are exemptions in developing accounting policies for regulatory account balances for two standards, namely, IFRS 3 Business Combinations and for those applying IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors

For preparers who develop accounting policies based on the Conceptual Framework, it is effective for annual periods beginning on or after 1 January 2020.

Impact The changes to the Conceptual Framework may affect the application of IFRS in situations where no standard applies to a particular transaction or event.

3. Summary of significant accounting policies

The significant accounting policies set out below have been applied consistently to all periods presented in the financial statements unless otherwise indicated.

3.1 Intangible assets

3.1.1 Intangible assets acquired separately

Intangible assets acquired separately are shown at historical cost less accumulated amortization and impairment losses.

Amortization is charged to profit or loss on a straight-line basis over the estimated useful lives of the intangible asset unless such lives are indefinite. These charges are included in other expenses in profit or loss. Intangible assets with an indefinite useful life are tested for impairment annually.

Amortisation periods and methods are reviewed annually and adjusted if appropriate.

3.1.2 Intangible assets generated internally

Expenditures on research or on the research phase of an internal project are recognized as an expense when incurred. The intangible assets arising from the development phase of an internal project are recognized if, and only if, the following conditions apply:

- The Company has the intention of completing the asset for either use or resale.
- The Company has the ability to either use or sell the asset.
- It is possible to estimate how the asset will generate income.
- The Company has adequate financial, technical and other resources to develop and use the asset.
- The expenditure incurred to develop the asset is measurable.
- It is technically feasible to complete the asset for use by the Company.

If no intangible asset can be recognised based on the above, then development costs are recognised in income statement in the period in which they are incurred.

3.2 Property, plant and equipment

3.2.1 Initial recognition

All property, plant and equipment assets are stated at cost less accumulated depreciation less accumulated impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Cost may also include transfers from equity of any gains/losses on qualifying cash flow hedges of foreign currency purchases of property, plant and equipment.

3.2.2 Subsequent costs

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.







3.2.3 Depreciation of property, plant and equipment

Depreciation on assets is calculated using the straight-line method to allocate their cost or revalued amounts to their residual values over their estimated useful lives, as follows:

The assets' residual values and useful lives are reviewed at the end of each reporting period and adjusted if appropriate. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable value.

The Company reviews the estimated useful lives of property, plant and equipment at the end of each reporting year.

3.2.4 Derecognition

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount, these are included in the income statement under operating income. When revalued assets are sold, the amounts included in the revaluation surplus are transferred to retained earnings.

3.2.5 Reclassification

When the use of a property changes from owner-occupier to investment property, the property is remeasured to fair value and reclassified as investment property. Any gain arising on re-measurement is recognized in the income statement to the extent that it reverses a previous impairment loss on the specific property, with any remaining recognized in other comprehensive income and presented in the revaluation reserve in equity. Any loss is recognized immediately in the income statement.

3.3 Inventories

Inventories are valued using standard costing method of valuation. The cost of inventories includes expenditures incurred in acquiring the inventories, production or conversion costs, and other costs incurred in bringing them to their existing location and condition. In the case of manufactured inventory and work in progress, cost includes an appropriate share of production overheads based on normal activity levels.

Net realizable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling.

3.4 Impairment of non-financial assets

The Company assesses annually whether there is any indication that any of its assets have been impaired. If such indication exists, the asset's recoverable amount is estimated and compared to its carrying value. Where it is impossible to estimate the recoverable amount of an individual asset, the company estimates the recoverable amount of the smallest cash-generating unit to which the asset is allocated. If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount an impairment loss is recognized immediately in profit or loss, unless the asset is carried at a revalued amount, in which case the impairment loss is recognized as revaluation decrease.

3.5 Financial instruments

Recognition and initial measurement

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.







Financial assets

Initial recognition and measurement of financial assets

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income (OCI), and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the entity's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Company has applied the practical expedient, the Company initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the practical expedient are measured at the transaction price determined under IFRS 15.

In order for a financial asset to be classified and measured at amortised cost or fair value through OCI, it needs to give rise to cash flows that are 'solely payments of principal and interest (SPPI)' on the principal amount outstanding. This assessment is referred to as the SPPI test and is performed at an instrument level.

The Compay's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both.

Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the market place (regular way trades) are recognised on the trade date, i.e., the date that the Company commits to purchase or sell the asset.

Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in three categories:

- Financial assets at amortised cost (debt instruments);
- Financial assets designated at fair value through OCI with no recycling of cumulative gains and losses upon derecognition (equity instruments);
- Financial assets at fair value through profit or loss (the company however has no financial instrument in this category).

Debt instruments

Subsequent measurement of debt instruments depends on the entity's business model for managing the asset and the cash flow characteristics of the asset.

There are three measurement categories into which the company classifies its debt instruments:

Amortised cost:

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in profit or loss when the asset is derecognised or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.

Fair value through other comprehensive income (FVOCI):

Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at fair value through other comprehensive income (FVOCI). Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognised in profit and loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method.





Fair value through profit or loss:

Assets that do not meet the criteria for amortised cost or FVOCI are measured at fair value through profit or loss. A gain or loss on a debt investment that is subsequently measured at fair value through profit or loss and is not part of a hedging relationship is recognised in profit or loss and presented net in the profit or loss statement within other gains/(losses) in the period in which it arises. Interest income from these financial assets is included in the interest income.

Other financial assets:

Other financial assets are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are presented as current assets, except for those maturing later than 12 months after the reporting date which are presented as non-current assets. These are initially recognized at fair value and subsequently measured at amortized cost using the effective interest method, less any impairment losses. These comprise trade receivables, unbilled revenues, cash and cash equivalents and other assets.

Trade and other receivables

Trade and other receivables are recognised initially at their transaction price and subsequently measured at amortized cost less loss allowances.

Expected credit losses

The entity applies the IFRS 9 simplified approach to measuring expected credit losses ECLs for trade receivables at an amount equal to lifetime ECLs. The ECLs on trade receivables are calculated based on actual credit loss experienced over the preceding three years on the total balance of non-credit impaired trade receivables.

The entity considers a trade receivable to be credit impaired when one or more detrimental events have occurred such as:

- significant financial difficulty of the customer; or
- it is becoming probable that the customer will enter bankruptcy or other financial reorganization;
- Impairment losses related to trade and other receivables are not presented separately in the consolidated income statement but are reported under the heading administrative expenses.

Business model:

The business model reflects how the entity manages the assets in order to generate cash flows. That is, whether the entity's objective is solely to collect the contractual cash flows from the assets or is to collect both the contractual cash flows and cash flows arising from the sale of assets. If neither of these is applicable (e.g. financial assets are held for trading purposes), then the financial assets are classified as part of 'other' business model and measured at fair value through profit or loss ('FVTPL"). Factors considered by the entity in determining the business model for a group of assets include past experience on how the cash flows for these assets were collected, how the asset's performance is evaluated and reported to key management personnel, how risks are assessed and managed and how managers are compensated.

Solely Payment of Principal and Interest (SPPI):

Where the business model is to hold assets to collect contractual cash flows or to collect contractual cash flows and sell, the entity assesses whether the financial instruments' cash flows represent solely payments of principal and interest (the 'SPPI test'). In making this assessment, the entity considers whether the contractual cash flows are consistent with a basic lending arrangement i.e. interest includes only consideration for the time value of money, credit risk, other basic lending risks and a profit margin that is consistent with a basic lending arrangement. Where the contractual terms introduce exposure to risk or volatility that are inconsistent with a basic lending arrangement, the related financial asset is classified and measured at FVTPL.







The entity reclassifies debt investments when and only when its business model for managing those assets changes. The reclassification takes place from the start of the first reporting period following the change. Such changes are expected to be very infrequent and none occurred during the period.

Equity instruments

The entity subsequently measures all equity investments at fair value. Where the entity's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair value gains and losses to profit or loss. Dividends from such investments continue to be recognised in profit or loss as other income when the company's right to receive payments is established.

Changes in the fair value of financial assets at fair value through profit or loss are recognised in other gain/(losses) in the statement of profit or loss as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

Impairment of financial assets

The entity recognises an allowance for Expected Credit Losses (ECLs) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Company expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12-months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

For trade receivables and contract assets, the Company applies a simplified approach in calculating ECLs. Therefore, the entity does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Company has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

The Company considers a financial asset in default when contractual payments are 60 days past due. However, in certain cases, the Company may also consider a financial asset to be in default when internal or external information indicates that the Company is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Company. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Derecognition

A financial asset is derecognised when:

The rights to receive cash flows from the asset have expired;

The entity has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and either:

(a) the entity has transferred substantially all the risks and rewards of the asset, or (b) the entity has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.





When the entity has transferred its rights to receive cash flows from an asset or has entered into a passthrough arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the asset is recognised to the extent of the entity's continuing involvement in the asset. In that case, the entity also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the entity has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the entity could be required to repay.

Financial liabilities

Initial recognition and measurement

The entity has classified all financial liabilities within the scope of IFRS 9 under loans and borrowings and other financial liabilities as appropriate. The entity determines the classification of its financial liabilities at initial recognition.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and other financial liabilities, net of directly attributable transaction costs.

Subsequent measurement

The measurement of financial liabilities depends on their classification as described below:

Loans and borrowings

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the Effective Interest Rate (EIR) method. Gains and losses are recognised in the consolidated income statement when the liabilities are derecognised as well as through the EIR amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included as finance costs in the consolidated income statement.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the consolidated income statement.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

3.6 Trade and other receivables

Trade receivables are amount due from customers for goods sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. Where the potential impact of discounting future cash receipts over the short credit period is not considered to be material, trade receivables are stated at their original invoiced value. These receivables are reduced by appropriate allowances for estimated irrecoverable amounts.





3.7 Cash and cash equivalents

Cash equivalents comprises of short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. An investment with a maturity of three months or less is normally classified as being short-term.

For the purpose of presenting the statement of cash flows, cash and cash equivalents are shown net of bank overdrafts.

3.8 Leases

The Company has adopted IFRS 16, "Leases" as issued by the IASB in July 2014 with a date of transition of 1 January 2019, which resulted in changes in accounting policies.

However, there is no implication to the company on the adoption of the standard as the current recognition and measurement basis of leases is in line with the requirement of the standard.

Definition of a lease

Under IFRS 16, a contract is, or contains a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration. The change in definition of a lease mainly relates to the concept of control.

IFRS 16 distinguishes between leases and service contracts on the basis of whether the use of an identified asset is controlled by the customer. Control is considered to exist if the customer has:

- The right to obtain substantially all of the economic benefits from the use of an identified asset; and
- The right to direct the use of that asset.

3.8.1 As Lessee

Leases, under which the Company's possess a contract that conveys the right to control the use of an identified asset for a period of time in exchange for consideration is disclosed in the Company's statement of financial position and recognized as a leased asset.

To assess whether a contract conveys the right to control the use of an identified asset for a period of time, the Company assesses whether, throughout the period of use, it has both of the following:

(a) the right to obtain substantially all of the economic benefits from use of the identified asset, and (b) the right to direct the use of the identified asset.

The Company has elected not to recognize right-of-use assets and lease liabilities for some leases of low value assets. The Company recognizes expenses associated with these leases as an expense on straight line basis over the lease term.

The Company presents right-of-use assets as a separate class under 'property and equipment'. The Company presents lease liability in finance lease liabilities in the statement of financial position.

3.8.2 As Lessor

The accounting policies applicable to the Company as a lessor are not different from those under IAS 17. The Company is not required to make any adjustments on transition to IFRS 16 for lease in which it acts as a lessor.

Operating leases

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease. Any balloon payments and rent free periods are taken into account when determining the straight-line charge.

These amendments do not have any impact on the Company's consolidafinancial statements.





3.9 Trade and other payables

Trade payables are obligations to pay for goods and services that have been acquired in the ordinary course of business. Accounts payable are classified as current liabilities if payment is due with one year or less. If not, they are presented as non-current liabilities.

Trade and other payables are stated at their original invoice value. The directors consider the carrying amount of other payables to approximate their fair value.

3.10 Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

Interest-bearing borrowings are stated at amortised cost using the effective interest method. The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments through the expected life of the financial liability.

3.11 Employee benefits

3.11.1 Defined contribution plan

In accordance with the provisions of the amended Pension Reform Act, 2014 the Company has instituted a Contributory Pension Scheme for its employees, where both the employees and the company contribute 8% and 10% of the employee total emoluments. The company's contribution under the scheme is charged to the profit and loss while employee contributions are funded through payroll deductions.

Obligations for contributions to the defined contribution pension plans are recognised as an employee benefit expense in profit or loss in the periods during which services are rendered by employees. Contributions to a defined contribution plan that is due more than twelve months after the end of the period in which the employees render the service are discounted to their present value.

Payments to defined contribution plans are recognised as an expense as they fall due. Any contributions outstanding at the year end are included as an accrual in the statement of financial position.

3.11.2 Defined benefit plan

A defined benefit plan is a post-employment benefit plan other than a define contribution plan. The company's net obligation in respect of defined benefit plan is calculated separately for each plan by estimating the amount of future benefit that employees have earned in return for their services in the current and prior periods; that benefit is discounted to determine its present value. Any recognized past service costs and fair value of any plan assets are deducted. The discount rate is the yield at the reporting date on AA credit-rated bonds that have maturity dates approximating the terms of the company's obligation and that are denominated in the currency in which the benefit are expected to be paid.

The calculation is performed annually by a qualified actuary using the projected credit unit method.

The company recognizes all actuarial gains or losses arising from defined benefit plans immediately in other comprehensive income and all expenses related to defined benefit plans in personnel expenses in profit or loss.

The company recognizes gains or losses on the curtailment or settlement of a defined benefit plan when the curtailment or settlement occurs. The gain or loss on settlement or curtailment comprises any resulting change in the fair value of the plan asset, any change in the present value of defined benefit obligation, any related actuarial gains or losses and past services cost that had not previously been recognised.

3.11.3 Termination benefit

Termination benefit are recognized as an expense when the company is demonstrably committed without realistic possible withdrawal, to a formal detail plan to either terminate employment before the normal retirement date, or to provide termination benefits as a result of an offer made to encourage voluntary redundancy. Termination benefit for voluntary redundancies is recognized as expenses if the company has





made an offer of voluntary redundancy and it is probable that the offer will be accepted, and the number of acceptances can be estimated reliably. If the benefits are payable more than 12 months after the reporting date, then they are discounted to their present value.

3.11.4 Short term employee benefits

These are measured on an undiscounted basis and are expensed as the related service is provided. A liability is recognized for the amount expected to be paid under short term cash bonus or profit sharing plans if the company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee, and the obligation can be estimated reliably.

3.12 Taxation

The tax expense for the period comprises current and deferred tax. Tax is recognised in the income statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the company's subsidiaries and associates operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and establishes provisions where appropriate.

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. However, if the deferred income tax arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit (loss), it is not accounted for. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities, and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities, where there is an intention to settle the balances on a net basis.

The tax effects of carry-forwards of unused losses or unused tax credits are recognised as an asset when it is probable that future taxable profits will be available against which these losses can be utilised.

Deferred tax related to fair value re-measurement of available-for-sale investments and cash flow hedges, which are charged or credited directly in other comprehensive income, is also credited or charged directly to other comprehensive income and subsequently recognised in the income statement together with the deferred gain or loss.

3.13 Provisions

Provisions are recognized when the company has a present obligation (legal or constructive) as a result of a past event, and it is probable that the company will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation.

3.14 Equity instruments

Equity instruments issued by the company are recorded at the value of proceeds received, net of costs directly attributable to the issue of the instruments. Shares are classified as equity when there is no obligation to transfer cash or other assets. Incremental costs directly attributable to the issue of equity instruments are shown in equity as a deduction from the proceeds, net of tax.

3.15 Revenue recognition

3.15.1 Sale of goods

Revenue from the sale of goods in the ordinary course of business is measured at the fair value of consideration received or receivable, net of returns, trade discounts and volume rebates. Revenue is recognized when persuasive evidence persists, usually in the form of an executed sales agreement, that the significant risks and rewards of ownership have been transferred to the customer, recovery of consideration is probable, the associated cost and possible return of goods can be estimated reliably, there is no continuing involvement with the goods, and the amount of revenue can be measured reliably. If it is probable that discount will be granted and the amount can be measured reliably, then the discount is recognized as a reduction of revenue as the sales are recognized.

3.16 Foreign currencies

Foreign currency transactions

Monetary items denominated in foreign currencies are retranslated at the exchange rates applying at the reporting date. Nonmonetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined.

Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated. Exchange differences are recognized in profit or loss in the period in which they arise except for:

• Exchange differences on foreign currency borrowings which are regarded as adjustments to interest costs, where those interest costs qualify for capitalization to assets under construction.

• Exchange differences on transactions entered into to hedge foreign currency risks.

• Exchange differences on loans to or form a foreign operation for which settlement is neither planned nor likely to occur and therefore forms part of the net investment in the foreign operation, which are recognized initially in other comprehensive income and reclassified from equity to profit or loss on disposal or partial disposal of the net investment.

3.17 Segment reporting

An operating segment is a component of an entity:

a) That engages in business activities from which it may earn revenue and incur expenses (including revenue and expenses relating to transactions with other components of the same entity);

b) Whose operating results are regularly reviewed by the entity's chief operating decision maker to make decisions about resources to be allocated to the segment, assess its performance; and

c) For which discrete financial information is available.

Quantitative thresholds have been set for determining operating segments for which separate information should be disclosed. Separate information should be disclosed for any operating segment:

• With revenue (including both external sales and intersegment transfers) that is 10% or more of the total revenue of all the operating segments;

• With assets that are 10% or more of the combined assets of all the operating segments; or

• Where its profit or loss which, in absolute terms, is 10 per cent or more of the greater, in absolute amount, of the combined reported profit of all profit making operating segments; and

• The combined reported loss of all loss-making operating segments.

An entity may combine information about operating segments that do not meet the quantitative thresholds with information about other operating segments that do not meet the quantitative thresholds to produce a reportable segment only if the operating segments have similar economic characteristics and share a majority of the aggregation criteria.





If the total external revenue reported by operating segments constitutes less than 75% of the entity's revenue, additional operating segments shall be identified as reportable segments until at least 75% of the entity's revenue is included in reportable segments.

If an operating segment is identified as a reportable segment in the current period in accordance with the quantitative thresholds, segment data for a prior period presented for comparative purposes shall be restated to reflect the newly reportable segment as a separate segment, even if that segment did not satisfy the criteria for reportability in the prior period, unless the information is not available and the cost to develop it is excessive.

The disclosure of segmental cash flows enables users to obtain a better understanding of the relationship between the cash flows of the business as a whole and those of its component parts and the availability and variability of segmental cash flows.

The company should disclose the factors used to identify its reportable segments. This should include the basis of organisation, for example by difference in products or services, geographical areas, regulatory environments or a combination of factors.

The company should disclose the types of products and services from which each reportable segment derives its revenues.

Information about other business activities and operating segments that are not reportable shall be combined and disclosed in an 'all other segments'.

The sources of the revenue included in the 'all other segments' category shall be described. An entity shall provide an explanation of the measurements of segment profit or loss, segment assets and segment liabilities for each reportable segment.

Certain entity wide disclosures are also required for all entities, including those entities that have a single reporting segment, including information about: products and services; geographical areas; and major customers. An entity shall report the revenues from external customers for each product and service, or each group of similar products and services, unless the necessary information is not available and the cost to develop it would be excessive, in which case that fact shall be disclosed. The amounts of revenue reported shall be based on the financial information used to produce the entity's financial statements.

An entity shall report geographical information for revenue from external customers:

i) Attributed to the entity's country of domicile and

ii) Attributed to all foreign countries in total from which the entity derives revenues. If revenues from external customers attributed to an individual foreign country are material, those revenues shall be disclosed separately. An entity shall disclose the basis for attributing revenues from external customers to individual countries.

An entity shall report geographical information for non-current assets (other than financial instruments, deferred tax assets, post-employment benefit assets, and rights arising under insurance contracts) Located in the entity's country of domicile; and

An entity shall provide information about the extent of its reliance on its major customers. If revenue from transactions with a single external customer amount to 10 per cent or more of an entity's revenues, the entity shall disclose that fact, the total amount of revenues from such customer, and the identity of the segment or segments reporting the revenues. The entity need not disclose the identity of a major customer or the amount of revenues that each segment reports from that customer. For the purposes of this IFRS, a group of entities known to a reporting entity to be under common control shall be considered a single customer, and a government (national, state, provincial, territorial, local or foreign) and entities known to the reporting entity to be under the considered a single customer.





4. Critical accounting estimates and judgement

The company makes estimate and assumption about the future that affects the reported amounts of assets and liabilities. Estimates and judgment are continually evaluated and based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances. In the future, actual experience may differ from these estimates and assumption.

The effect of a change in an accounting estimate is recognized prospectively by including it in the comprehensive income in the period of the change, if the change affects that period only, or in the period of change and future period, if the change affects both the estimates and assumptions that have a significant risks of causing material adjustment to the carrying amount of asset and liabilities in the next financial statements are discussed below:

a) Defined benefit obligation

The present value of defined benefit obligation depends on a number of factors that are determined on an actuarial basis using a number of assumptions. The assumptions used in determining the defined benefit obligation include the discount rate, the company determines the discount rate at the end of each year. This is the interest rate that should be used to determine the present value of estimate future cash outflows expected to be required to settle the pension obligations. In determining the appropriate discount rate, the company considers the interest rates of high- quality corporate bond that are denominated in the currency in which the benefits will be paid, and have terms to maturity approximating the terms of the defined benefit obligation.

b) Impairment of available-for-sale equity financial assets

The company determines that available-for-sale equity financial assets are impaired when there has been a significant or prolonged decline in the fair value below its cost. This determination of what is significant or prolonged requires judgment. In making this judgment, the company evaluates among other factors, the normal volatility in share price, the financial health of the investee, industry and sector performance, changes in technology, and operational and financing cash flow. Impairment may be appropriate when there is evidence of deterioration in the financial health of the investee, industry and sector performance, changes in technology, and operational cash flows.

The fair values of financial instruments where no active market exists or where quoted prices are not otherwise available are determined by using valuation techniques. In these cases the fair values are estimated from observable data in respect of similar financial instruments or using models. Where market observable inputs are not available, they are estimated based on appropriate assumptions. Where valuation techniques (for example, models) are used to determine fair values, they are validated and periodically reviewed by qualified personnel independent of those that sourced them.

To the extent practical, models use only observable data; however, areas such as credit risk (both own credit risk and counterparty risk), volatilities and correlations require management to make estimates. Changes in assumptions about these factors could affect the reported fair value of financial instruments.

c) Impairment of property, plant and equipment and intangible assets

Management is required to make judgement concerning the cause, timing and amount of impairment. In the identification of impairment indicators, management considers the impact of changes in current competitive conditions, cost of capital, availability of funding, technological obsolescence, discontinuance of services and other circumstances that could indicate impairment exist.

d) Others are:

- i Residual values of items of property, plant and equipment.
- ii Estimated useful lives of item of property, plant and equipment.
- iii Allowance for obsolete stock.
- iv Allowance for doubtful debts.





5. Risk management framework

The primary objective of the company's risk management framework is to protect their stakeholders from events that hinder the sustainable achievement of financial performance objectives, including failing to exploit opportunities. Management recognises the critical importance of having efficient and effective risk management systems in place.

The company has established a risk management function with clear terms of reference from the board of Directors, its committees and the executive management committees.

This is supplemented with a clear organizational structure with documented delegated authorities and responsibilities from the board of directors to executive management committees and senior managers. Lastly, the Internal Audit unit provides independent and objective assurance on the robustness of the risk management framework, and the appropriateness and effectiveness.

Strategic risks – This specifically focused on the economic environment, the products offered and market. The strategic risks arises from a company's ability to make appropriate decisions or implement appropriate business plans, strategies, decision making, resource allocation and its inablity to adapt to changes in its business environment.

Operational risks – These are risks associated with inadequate or failed internal processes, people and systems, or from external events.

Financial Risks – Risk associated with the financial operation of the company, including underwriting for appropriate pricing of plans, provider payments, operational expenses, capital management, investments, liquidity and credit.

The board of directors approves the company's risk management policies and meets regularly to approve any commercial, regulatory and organizational requirements of such policies. These policies define the company's identification of risk and its interpretation, limit structure to ensure the appropriate quality and diversification of assets, align underwriting to the corporate goals, and specify reporting requirements to meet.

5.1 Strategic risks

The following capital management objectives, policies and approach to managing the risks which affect its capital position are adopted by the company.

i) To maintain the required level of financial stability thereby providing a degree of security to clients and plan members.

ii) To allocate capital efficiently and support the development of business by ensuring that returns on capital employed meet the requirements of its capital providers and of its shareholders.

iii) To retain financial flexibility by maintaining strong liquidity.

iv) To align the profile of assets and liabilities taking account of risks inherent in the business and regulatory requirements.

v) To maintain financial strength to support new business growth and to satisfy the requirements of the regulators and stakeholders.

5.2 Operational risks

Operational risk is the risk of direct or indirect loss arising from a wide variety of causes associated with the company's processes, personnel, technology and infrastructure, and from external factors such as provider tariffs, medical costs, premium review for adequacy, prompt premium payments and collctions. Others are legal and regulatory requirements and generally accepted standards of corporate behaviour. Operational risks arise from all of the company's operations.

The company's objective is to manage operational risk so as to balance the avoidance of financial losses and damage to the company's reputation with overall cost effectiveness and to avoid control procedures that restrict initiative and creativity.





The primary responsibility for the development and implementation of controls to address operational risk is assigned to senior management within each unit. This responsibility is supported by the development of operational standards for the management of operational risk in the following areas:

- requirments for appropriate segregation of duties, including independent authorisation of transactions.
- requirements for the reconciliation and monitoing of transactions.
- compliance with regulatory and other legal requirements.
- documentation of controls and procedures.
- training and professional development.
- ethical and business standards.

5.3 Financial risks

The company's operations expose it to a number of financial risks. A risk management programme has been established to protect the company against the potential adverse effects of these financial risks. There has been no significant change in these financial risks since the prior year and they are:

- Credit risks
- Liquidity risks
- Market risks

a) Credit risks

The company invests some of its surplus funds in high quality liquid market instruments. Such investments have a maturity no greater than three months. To reduce the risk of counterparty default the company deposits the rest of its surplus funds in approved high quality banks. Concentrations of credit risk with respect to customers are limited due to the company's customer base being Large and unrelated. Customers are assessed for credit worthiness and where appropriate the company obtains security for its exposure to the risk of default. Credit limits are also imposed on customers and reviewed regularly.

The Company allows an average debtors period of 30 days after invoice date. It is the Company's policy to assess trade receivables for recoverability on an individual basis and to test for impairment where it is considered necessary. In assessing recoverability the Company takes into account any indicators of impairment up until the reporting date.

b) Liquidity risks

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial instruments.

The Company employs policies and procedures to mitigate it's exposure to liquidity risk.





c) Market risks

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: foreign exchange rates (currency risk), market interest rates (interest rate risk) and market prices (price risk).

d) Currency risk

Currency risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates.

The company's principal transactions are carried out in Naira and its financial assets are primarily denominated in the Naira and its exposure to foreign exchange risk is minimal.

6. Capital management

The Company seeks to optimise the structure and sources of capital to ensure that it consistently maximises returns to the shareholders and customers.

The Company's approach to managing capital involves managing assets, liabilities and risks in a coordinated way, assessing shortfalls between reported and required capital level on a regular basis.

Approach to capital management

In the management of its capital, the Company has certain objectives which it intends to achieve. These include:

The safeguarding of the Company's ability to continue as a going concern, so that it can continue to provide returns to shareholders and benefits to other stakeholders by pricing products commensurately with the level of risk.

Consistently with others in the industry, the Company monitors capital on the basis of the debt-to-capital ratio. This ratio is calculated as net debt ÷ capital:

Net debt is calculated as total liabilities (as shown in the statement of financial position) less cash and cash equivalents. Capital comprise all components of equity (i.e. ordinary shares, share premium and retained earnings).
